- 4) In the event of any information or document submitted by the applicant being found to be incorrect or misleading Udaan reserve the right to cancel the admissions of the candidate without any fees refund
- 5) In case the student wishes to pursue a course other than the one for which admission was taken he or she can do so by giving a return request to the management .however this option is available only within 15 days from the date of admission for the course in initially applied for
- 6)Udaan reserves the right to reject any applications without giving any reason reserves the right to reject any applications without giving any reason.

#### Fees

- 1)Registration and course fee is not refundable under all circumstances
- 2) All course fees must be paid in full or in case of any installment plan the agreed installment paid prior to the start of the course in the event that the installment plan is not been paid as per the agreed schedule Udaan Reserves the right to have the students withdraw from the course

#### **Misconduct and Disciplinary Action**

Serious Misconduct

Indulgence in the following practices shall constitute serious misconduct and the student may be expelled and his admission terminated from the institute without any warning

- b) Wilful destruction of Udaan property

- d) Ragging

- g)Cheating in examination class or in assignment
- h)Discrimination on the basis of religion caste gender race or any other unlawful ground extra
- i) Including in Act which brings disrepute to other student faculty for Udaan j)Entering into the contract by misrepresentation

#### **Minor Misconduct**

Indulgence in the following practices shall constitute serious misconduct and the student shall be issued a warning letter which will be followed by termination in case of no improvement

- a) Failure to comply with the policy and procedure of Udaan
- b) Failure to maintain satisfactory academic progress
- c) Absent in exam without prior intimation
- d) Absconding (that is absent without information in writing)
- e) Non computation of assignment given by the trainer in due time
- f) Disobedience of instructor or trainer or management
- g) Not-adherence to groom and dress code policy
- h) Non serious attitude in class
- Refusal To Identify of one self when requested by authorised Udaan officials
- j) Unauthorised access and use of Udaan property and facilities

#### Theft, Loss / damage to udaan property

Student agrees to compensate Udaan against any loss or damage caused to udaan property due to his / her will full atc or carelessness or negligence

#### **Abuse of electronic Communications**

The following shall amount to abuse of electronic Communications: a)Using Institute of personnel telecommunication or Data communication network for illegal improper uses

#### Attendance

- a) Minimum 70% attendance in class is compulsory to become eligible to appear for the examinations
- b) Minimum 85% attendance during clinical internship is compulsory c)In case the attendance fall short the students shall not be allowed to appear for the examinations

#### **Examinations and certifications**

- a) It is compulsory for the student to appear for the Weekly assessment module based assessment final foundations exams and internship exams. b)The course completion certificate (Udaan) shall be awarded only after payment of full course fee, passing the pre-internship examination and clinical internship
- c)If a student fails to achieve minimum qualifying marks there shall we provide within opportunity to reappear for remediation exams however a cost of rupees 2000 per remediation exams would be charge for each such further exams

#### **Clinical internship**

- a)In order to qualify for the clinical internship the student must secure at least 70% marks in in pre-internship exam
- b)The management will always endeavor to refer students for clinical intenship in organisations based in nearby areas . however specifically request' from the students for location preference shall not be entertain by the management
- c)During the clinical internship students shall be subject to the rules and regulations as applicable to the organisation where they are undergoing their clinical internship

#### **Placements**

- a)Udaan provides placement support to the student who have successfully complete the course and does not guaranteed placemen to any student
- b)only students who have completed clinical internship and the examination shall be eligible for the placement support
- c)placement support will be available for the period of 3 months from the end of clinical internship
- d)unlimited placement of the student depends on their performance in their course and interview and other factors, the decision to join any organisation rest with the student and Udaan is not responsible for there finalization of salary locations or other employment system

## **Dress Code policies**

a)Maintaining a proper dress code is a key part of training provided a Udaan. at all the times students should be dressed in appropriate clothing t-shirts jeans and sports shoes are not permitted b)During the training programme a student has to wear a uniform provided by Udaan.
